

Pursuant to Regulation 30 (2) read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform you that the Board of Directors of the company, in its meeting held on 25th August, 2020, had appointed Mr. Vaibhav Gupta as an Independent Director and an intimation of the same was sent to you vide our letter dated 25th August, 2020. The appointment of Mr. Vaibhav Gupta was based on, inter-alia, confirmation given by him in DIR-8 that he has not incurred any disqualification under section 164(2) of the Companies Act, 2013 in the company mentioned by him in the said form in the previous financial year and that he at present stood free from any disqualification from being a director. Accordingly, the Board of Directors of the Company meet on 04th September, 2020 at 03:00 P.M. via VC and have passed a resolution to the effect that appointment of Mr. Vaibhav Gupta shall be treated as null and void.
